§1 GENERAL PROVISIONS

4. Every person visiting the Website (hereinafter: the "User") undertakes to comply with these Terms and Conditions.

§2 WEBSITE FUNCTIONALITIES

1. The Website contains information about the following products:
 - whole shell-less chicken eggs,
 - shell-less chicken egg yolks,
 - shell-less chicken egg whites.
2. The User can download PDF data sheets for the above products from the Website.
3. The Website includes recipes using the above products.
4. A contact form is available on the Website, enabling the User to send a message to the Administrator.
5. The contact form requires the User to provide:
 - first name,
 - e-mail address,
 - message content,and successfully complete the reCaptcha verification form.
6. Use of the contact form is voluntary, but requires consent to the processing of personal data to the extent necessary to handle the message. The scope of personal data processing and the cookies policy are available on the Website as downloadable files shown in the footer (as the "Cookies Policy" and "Privacy Policy" links).
